NW 1/4 SEC. 4, LIBERTY TWP. T5S, R1E



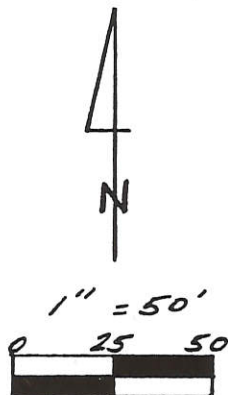

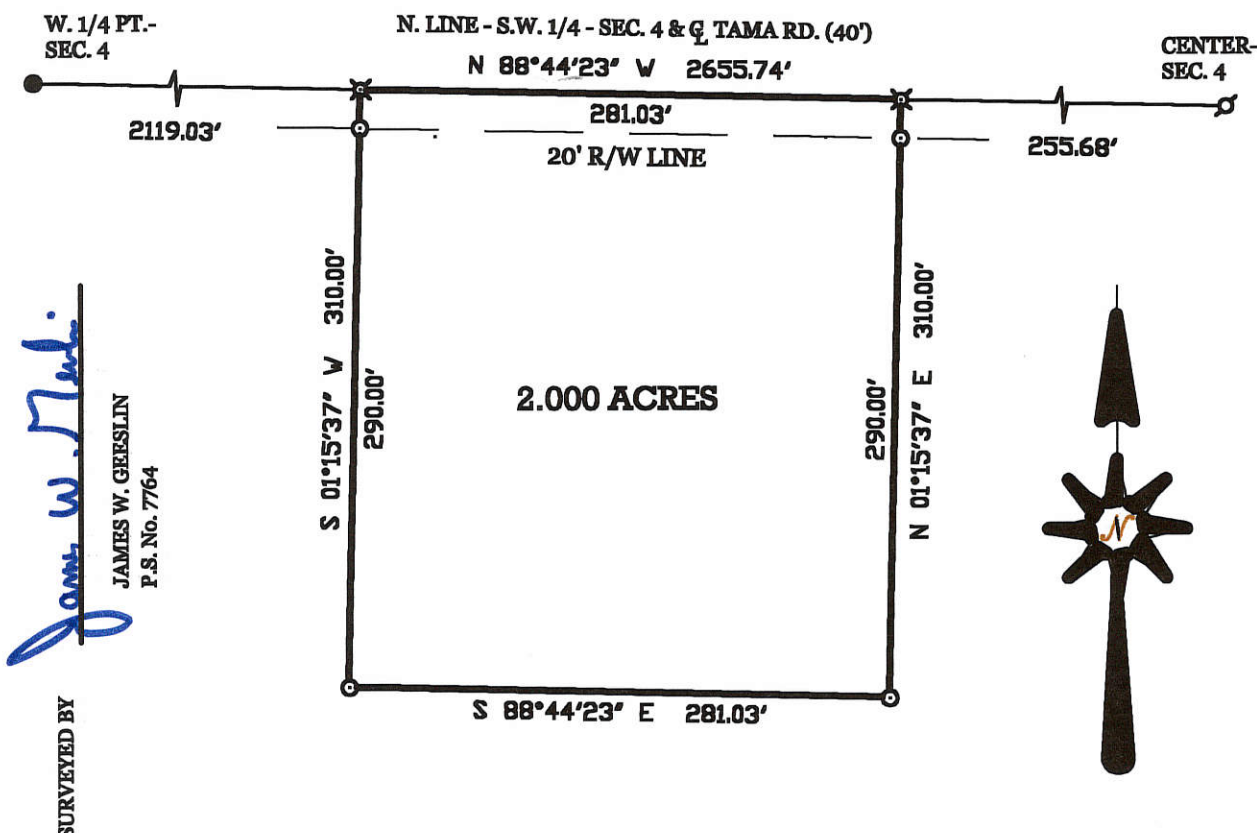
LOCATION SKETCH

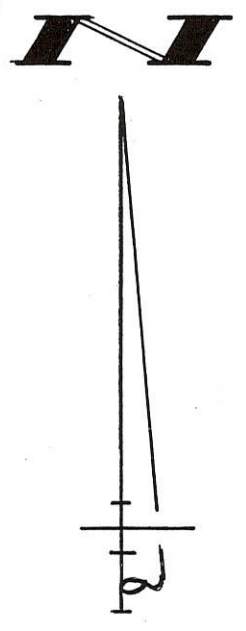

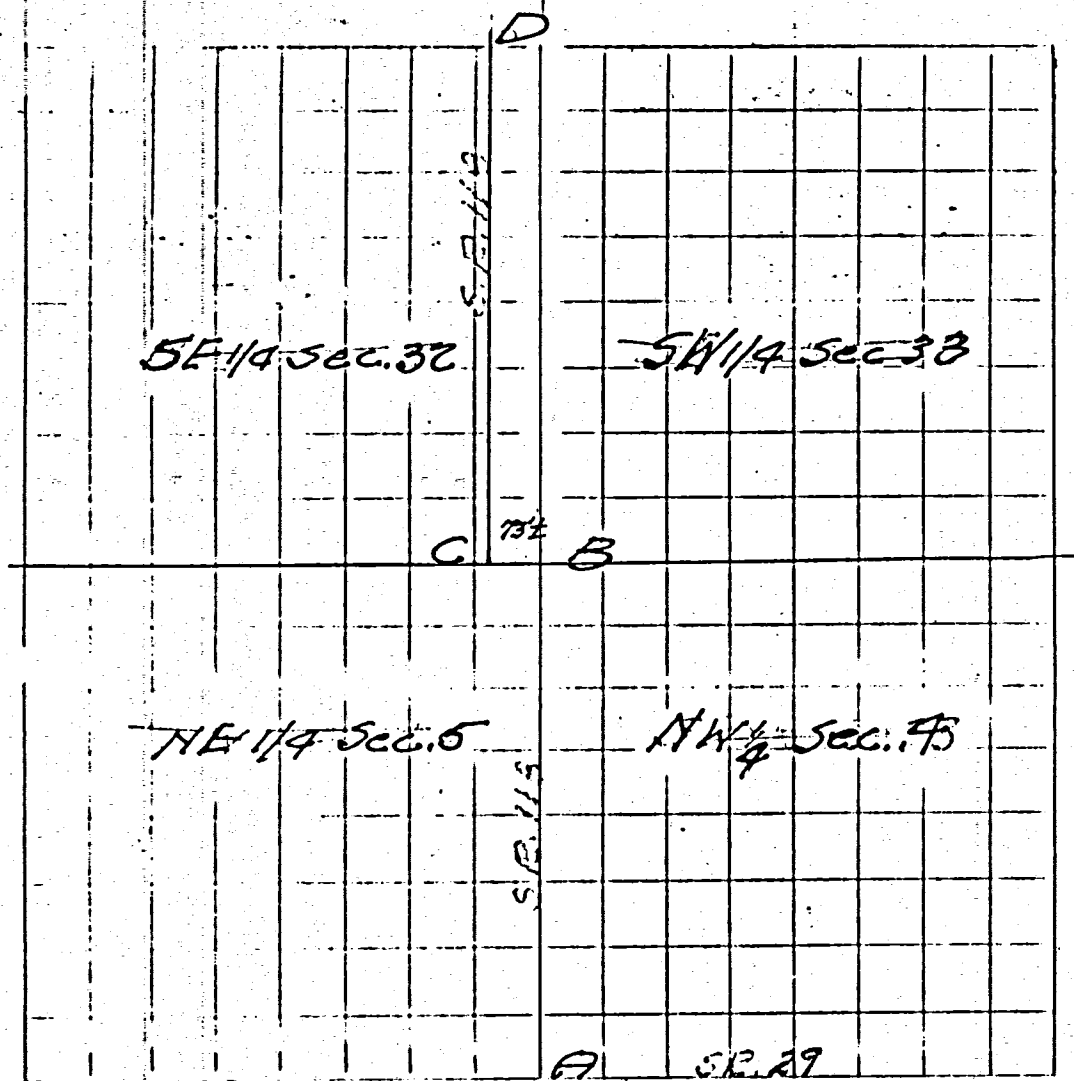

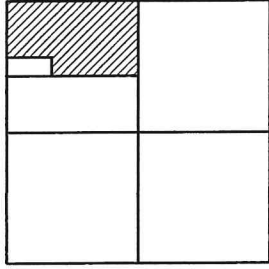

LOCATION SKETCH



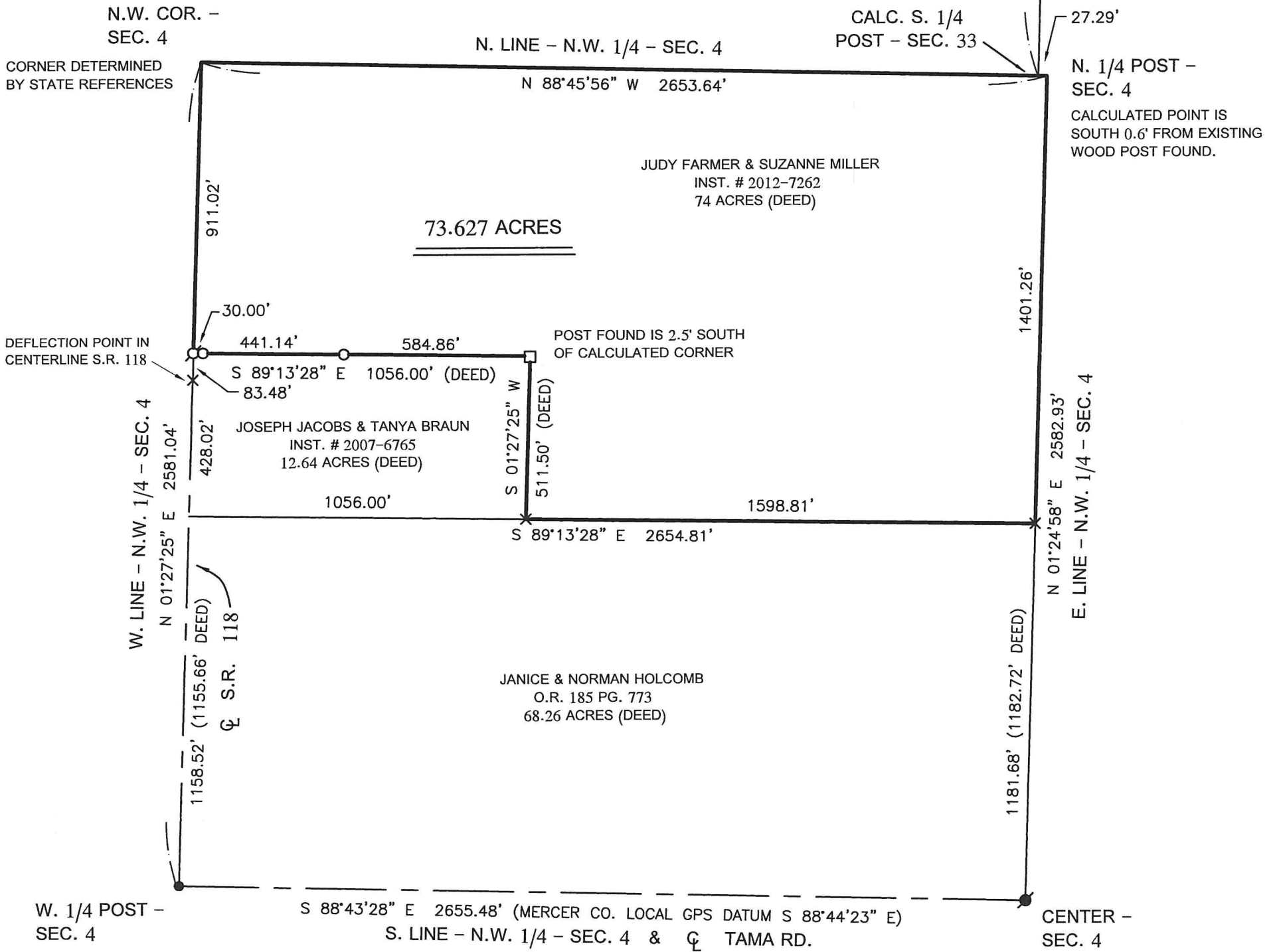
