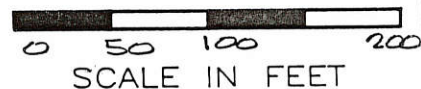
LOCATION PLAN

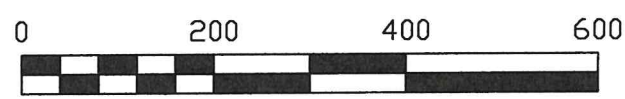

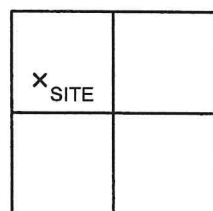
