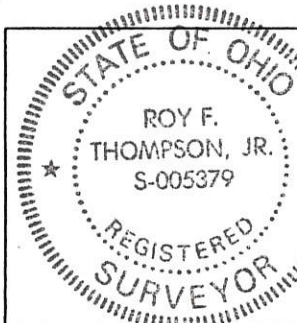

Surveyed the above section from Apr. 15 to May 2nd 1803. I found the north line of Section to be 80 chains. Ran North 80 chains and find stump of S.W. Burr Oak with mark on it and agreeing there with the body and place where the N.E. Burr Oak stood agreeing in bearing and distance and with bearing and distance applied to the west line of the Section ran east 32.80 ch. as given on the note and at 24 struck a stream running north and at 32.80 chains the bank of the St. Marys River where I find Red Oak. Applying the course S. 61 1/2° E. in reverse and deducting the 150 corner to the same stream then applying the course and distance of the river I find the post every turn of the river and at end of East course find a Red Oak.

Went to S.E. cor. and applied the course 76.21 as given on one of notes and find on measuring that I find 1 chain which was with them 571 50 ch. chain the line comes out to agree with said Red Oak and when by chopping into four marks it agreed for the witnesses from both directions.

Applying the traverse table and computing I find the latitude and departure on the 34 and find and also on the 78 see that close fairly small and find 94.26 acres in the N. 1/2 N. 6 1/4 and 78.01 in the E. N. E. 1/4. The river was therefore made the line of 23 1/2 from the end of the course 32.80 and Sec 14.42 ended there. From the west part of 26 7.45 R. 2 E. North I find 30 links and 40 chains as 40.30 and at 80 rods east stone North to stone planted long years ago at S.W. E. of S.W. corner of Sec 23 T. 4 S. R. 2 E. 40.33

At E. S.W. cor. I then examined for remains of S.W. oak and find some slight evidence of it. At S. 1/4 Post I find that the oak 3 W. of 1/4 Post had sprouts grown up penetrating it and I find very distinct remains of the 4ch. lat. agreeing exactly with the point midway on the south line of the Section.
