LOCATION SKETCH

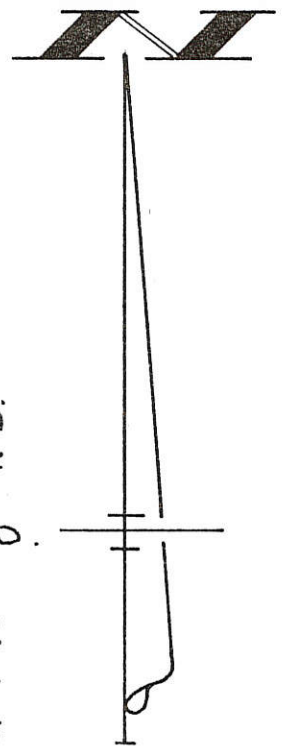
