NOTE: WE WERE CONTRACTED TO PERFORM A RETRACEMENT SURVEY ON THE JOANNE C. LUTHMAN 79.63 AC. TRACT AS RECORDED IN INST. #201200001672. WE ABSTRACTED THE CHAIN OF TITLE BACK TO JAN. 23, 1856 WHEN ISHMAEL & MARTHA KEITH SOLD THE EAST HALF OF THE NORTHWEST QUARTER OF SEC. 1 TO WILLIE ANN BUNN (BRYAN?) IN DEED BOOK W PAGE 43. AT THAT TIME THE KEITHS ALSO OWNED THE WEST HALF OF THE NORTHWEST QUARTER OF SEC. 1. ON NOV. 2, 1859 THE KEITHS TRANSFERRED THE WEST HALF OF THE NORTHWEST QUARTER TO GREEN KEITH. IT APPEARS THAT THE EAST HALF OF THE NORTHWEST QUARTER OWNED BY JOANNE C. LUTHMAN IS THE SENIOR TRACT IN THE QUARTER SECTION. IT APPEARS FROM ANCIENT CORNER POST FOUND AT THE SOUTHEAST AND SOUTHWEST CORNERS OF THE PROPERTY AND OCCUPATION AT THE NORTHWEST CORNER OF THE QUARTER SECTION THAT AN EQUAL DIVISION WAS NOT CREATED, LEAVING THE EAST HALF SLIGHTLY SMALLER THAN THE WEST HALF, 81.220 ACRES VS. 80.961 ACRES. IT APPEARS THAT 20 CHAINS WAS CUT OF THE EAST HALF OF THE QUARTER SECTION WITHOUT SURVEYING THE ENTIRE TRACT. THE REASON BEHIND THE ADDITIONAL ACREAGE IN SAID QUARTER SECTION IS THAT ALL THE LINES OF SAID QUARTER SECTION MEASURE LONGER THAN A STANDARD QUARTER SECTION 40 CHAINS X 40 CHAINS (2640 FEET X 2640 FEET).
