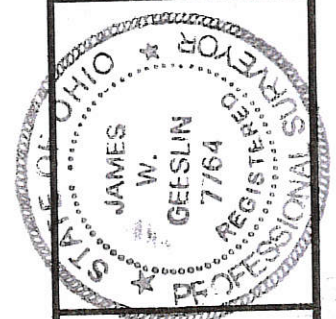
LOCATION SKETCH
