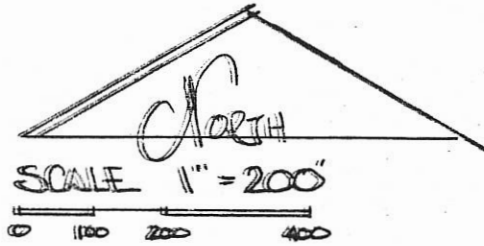
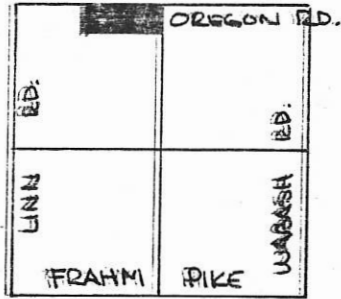

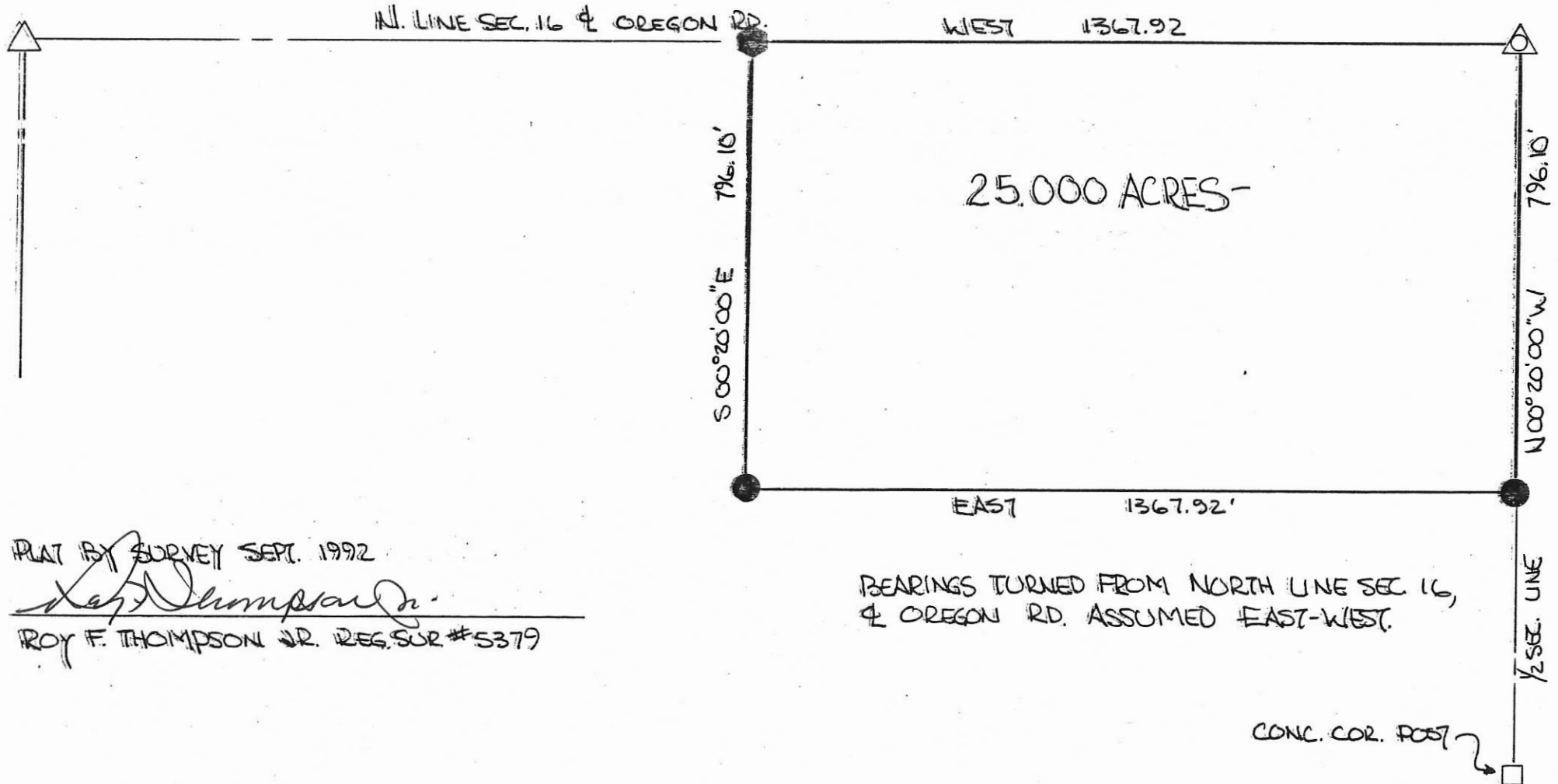
LOCATION PLAT.

LOCATION PLAT



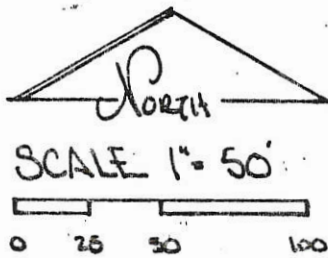
