LOCATION SKETCH

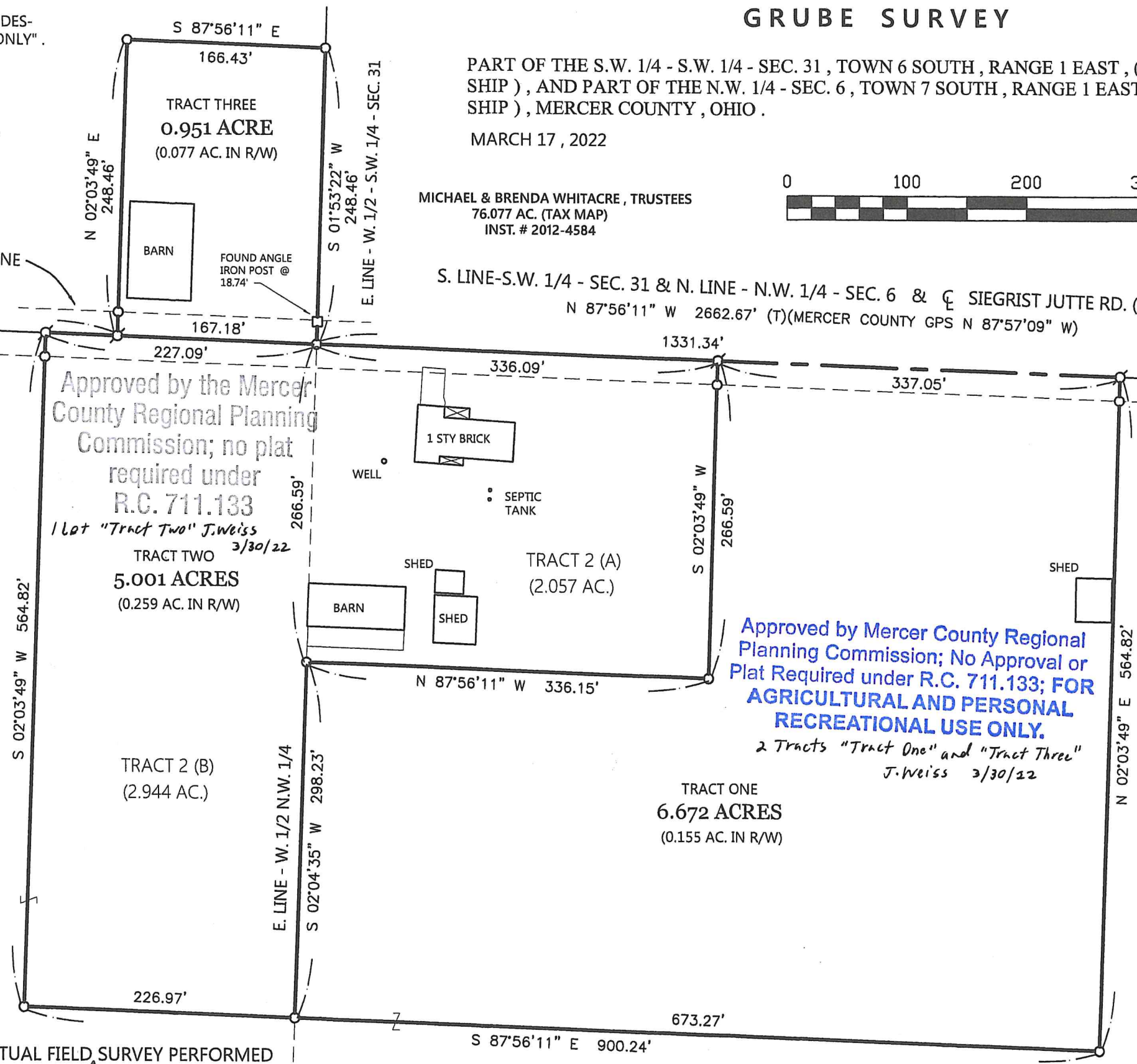

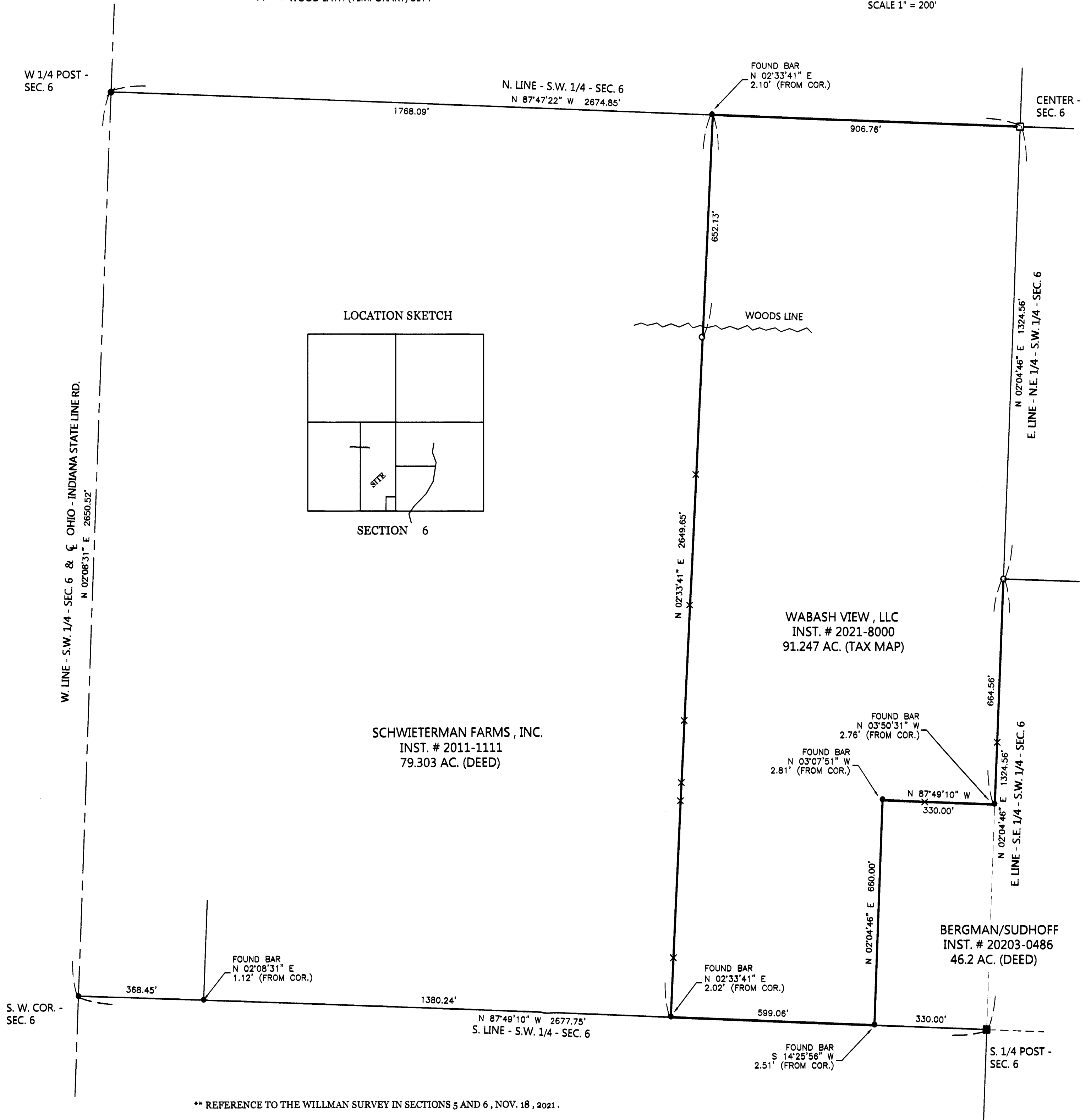

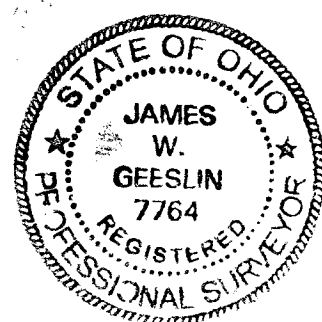
